The North Figueroa Association would like to **THANK YOU**, our property owners through this pandemic. We know that this is a challenging time right now and to have your support means so much to all of us.

Safe Team- GSSi currently running vehicle patrols 24 hours per day, 7 days per week. GSSi continues to respond to your calls at 800-350-1944. We have suspended foot patrol until it is safe for them to return.

Clean Team- Chrysalis is out on the streets 6 days per week. Disinfecting street furniture, sweeping the sidewalks, removing graffiti, removing trash, bulky Item pick up, pressure washing sidewalks, watering/upkeep of the plants and trees. Chrysalis continues to answer your service calls at: 213-995-6943.

Old LA Farmers Market- Open Tuesdays from 3-7pm. CalFresh EBT is accepted with up to \$30 Market Match being distributed.

Council District #1 Updates- COVID 19 and Federal Court rulings have changed how we address encampments and assist people experiencing homelessness in the City of LA.

The CDC has issued guidelines that no encampments (public right of way/ public property) are to be cleared as this could disperse a possible carrier and make it difficult to impossible for outreach teams to do well being checks or provide COVID test results if people have been displaced. In addition, tents and tarps can stay up to provide shelter in an attempt for them to stay inside and isolate like we ask the public that is housed to stay at home.

The City of LA has moved over three thousand people 55 and older or living with medical conditions indoors, there are thousands more remaining on our sidewalks. deemed bulky items at encampments as personal property unless it is an observed health hazard (blood, urine, feces, bugs). The City of LA is appealing this ruling but until it's overturned we must follow the order.

The City of LA is looking for City property to store these items for 90 days so we can be ready when we are allowed to fully clean encampments if the ruling is not overturned. At this time, LA Sanitation can only spot clean the area and remove health hazards.

We do not know when the CDC or LA County Department of Public Health will change their guidelines to allow us to fully clean encampments and require tents and tarps to come down. Our teams also ask for voluntary surrender of anything they deem to be trash.

The Economic and Workforce Development Department (EWDD) is administering the program on behalf of the City.

The fund is providing \$3 million in grants at \$5,000 or \$15,000 to the City's microentrepreneurs, small businesses, and 501(c)(3) non-profits.

There are a total of 6 rounds of funding, with finalists notified each round.

The North Figueroa Assn. knows that access to Fresh Produce is important to our community. Currently we are able to provide the Old L.A. Farmers Market as an open air Essential Service. Please be respectful of others and adhere to the strict guidelines provided with your safety in mind.
